## **Course Description**

This course is a "second" course in database systems. It will be focused on the study of the principle and implementation of database management systems. We will start with an in-depth review on the fundamentals of database design and database programming (e.g., chapters 2-10 in the textbook). We then concentrate on the detailed discussions of the following topics in database management systems: system architecture, efficient data manipulation, query processing, crash recovery, concurrency control, transaction processing, database security and integrity, and bigdata.

## **Course Prerequisites**

Familiarity in principle with basic knowledge of the relational database modeling and programming, and background in undergraduate-level data structures, algorithms and computer programming.

## **Course Learning Outcomes**

At the conclusion of the course, the students will be well-prepared for database programming and database development, and have an in-depth understanding of the principle of database management systems.
